The AFT has been concerned for some time about minority representation in NHCC's student body and faculty. We have

representation in NHCC's student body and faculty. We have sought to recruit minority faculty members into the AFT in part in order to focus attention on the problem. The 1986 Statistical Supplement published by the Texas Higher Education Coordinating

Board reported that of the 444 NHCC faculty that year, only 30 were black (12), Hispanic (8), or Asian (10). The same problem

exists in our student population. In a Board meeting presenting her ethnic analysis of NHCC's student population for the fall semester of 1988, Registrar Teresa Phillips reported on our low minority population, noting that "We are very white." These figures are not representative of our constituency in the areas comprising the College District.

The AFT member most active in minority student recruiting efforts is Spanish and French instructor Bertha Parle of the South Campus. She has sent me the following report concerning some of her recent activities:

I am very pleased finally to be taking part in NHCC's efforts to attract minority students to our campuses.

We have an image to change; we are seen by the poor black and Hispanic community as a primarily white upper-middle class establishment in the fancy suburbs. Somehow, they feel more comfortable going towards town than approaching us. Going out into the community, taking minority staff or faculty with us, will help to change this image.

I sent memos last spring to offer my services to the Public Information Office and to keep them informed of the opportunities for us to be present in the Hispanic community. I always received written responses but was disappointed that a more active involvement was slow in coming. I was delighted, however, when last fall Dr. Airola and Dr. Head began to make concrete plans to go into the poor junior highs in the area and asked me to participate. I felt that the action was long overdue.

Our first effort was very successful. We, in cooperation with UH, had an information night at St. Leo The Great Catholic Church on Jan. 14th. UH and NHCC set up information tables to provide oral and written information to the parents of prospective There were several representatives on hand to provide answers to questions, and hand out literature. We were impressed by the presence of two of our board members, Dr. Dwayne Collins and Dr. Don Stewart. Mr. Jack Neary, a MacArthur counselor, and Mrs. Jean Neary, an NHCC piano instructor, were also on hand to answer questions. In order to reach out and be more effective in the future, we need to publicize better and to organize a short presentation that targets our audience. For many of those present, this was their first family experience with collegelevel applications and information. So they were understandably confused and disoriented. Responses to their questions were frequently met by blank stares. They all left with stacks of literature, but my concern is whether they will be able to wade through

I believe we can learn from this experience and adapt to the needs of the people we are trying to reach.
